**FEDERAL PELL GRANT:** Due to federal regulations, regarding Year-Round Pell, if you are enrolled for Summer 2019 in courses that work towards your degree we are required to process the Pell grant. ### STAFFORD LOAN FUNDING (Subsidized/ Unsubsidized)

 Using Loan funding for the Summer 2019 semester will reduce the loan funding available to you for the upcoming academic year (Fall 2019 & Spring 2020 semesters).

### **NYS TAP GRANT (Tuition Assistance Program)**

- Students must be enrolled for at least 6 credits, have been full-time in the prior term and have earned at least 24 credits in the 2018-2019 academic year, per TAP Accelerated Study regulations.
- You must apply for the TAP grant online at www.tap.hesc.ny.gov. Purchase College is listed as <u>SUC at Purchase</u> and the school code is 0970.
- General admission students are eligible for 8 semesters of TAP and EOP students are eligible for 10 semesters of TAP.
- If you will be using summer TAP, you must resubmit the TAP application with a code for summer. Under "Manage my Account- Change TAP College Code", you must request TAP for Summer 2019 in order to receive a TAP payment for Summer 2019. Please be aware that New York State will delay your Summer TAP payment to Purchase College.
- Please be aware that for the last several years, students who have a TAP Grant for the summer, fall, and spring of an award year have their summer TAP disbursement delayed until October of the following year. As a result, students with a Summer 2019 TAP Grant (and a Fall 2019 and Spring 2020 TAP Grant) will not have their Summer 2019 TAP disbursed until October 2020. Please plan accordingly, as this will affect any potential refund(s) that you may receive.
