**The 2019-2020 FAFSA and any supporting documentation must be received by APRIL 10, 2019.** You can complete your FAFSA application online at [www.fafsa.ed.gov](http://www.fafsa.ed.gov). Purchase College's school code is 006791.

**Financial aid is only available to matriculated students for degree applicable coursework.** Students must already be matriculated effective for Summer 2019 to qualify.

**Your summer bill is your responsibility-** if all documents are not submitted in a timely manner you will need to either pay your summer costs out-of-pocket or be dropped from your coursework.

**Federal funding will not be disbursed until mid-July. Accelerated NYS TAP funds will not be disbursed until Fall 2019.** Please plan ahead for any out of pocket expenses such as deposits, books, supplies, airfare/transportation.

**Students must be meeting the minimum Satisfactory Academic Progress (SAP) Standards.** Our office will calculate SAP after Spring 2019 grades are available. Failure to meet SAP requirements will result in disqualification for federal financial aid.

**In most cases, using financial aid during the Summer 2019 term is like taking an advance on financial aid for the rest of the year, reducing your aid during Fall 2019 and Spring 2020.**

**Loan funding-** Student's borrowing loans must submit all necessary documentation prior to their last day of attendance for their summer sessions.

**Class Enrollment for Summer-** If the number of credits that you are taking changes, you must let the Office of Student Financial Services know immediately via email at: [sfs@purchase.edu](mailto:sfs@purchase.edu). Failure to maintain the number of credits your financial aid was based on can result in reduced awards or ineligibility for financial aid.

**FEDERAL PELL GRANT:** New federal regulations regarding Year-Round Pell require our office to process the Pell grant if you are enrolled for Summer 2019 in degree applicable coursework.

- Pell used in summer counts towards your [600% lifetime eligibility](#) (equal to 6 years full time study during fall/spring) for this grant. If you are close to the 600% lifetime eligibility you may run out of Pell prior to completing your degree.
- You will not qualify for Pell in Spring 2020 if you are full time in Summer 2019, full time in Fall 2019 and plan to take less than 6 credits in Spring 2020.

- You must apply for the TAP grant online at [www.tap.hesc.ny.gov](http://www.tap.hesc.ny.gov). Purchase College is listed as SUC at Purchase and the school code is 0970.
- General admission students are eligible for 8 semesters of TAP and EOP students are eligible for 10 semesters of TAP.
- If you will be using summer TAP, you must resubmit the TAP application with a code for summer. Under "Manage my Account- Change TAP College Code", you must request TAP for Summer 2018 in order to receive a TAP payment for Summer 2019. Please be aware that New York State may delay your Summer TAP payment to Purchase College.
- Please be aware that for the last several years, students who have a TAP Grant for the summer, fall, and spring of an award year have their summer TAP disbursement delayed until October of the following year. As a result, students with a Summer 2019 TAP Grant (and a Fall 2019 and Spring 2020 TAP Grant) will not have their Summer 2019 TAP disbursed until October 2020. Please plan accordingly, as this will affect any potential refund(s) that you may receive during Summer 2019 as well as Fall 2019 and Spring 2020.
